

# Hunter Valley Station Visitors Form

All visitors to Hunter Valley Station are advised that numerous hazards exist, and care must be taken at all time to avoid accidents. Access over the Hunter Valley farm track is only available for 4WD vehicles, walking, mountain biking and horse riding (motorcycles and all-terrain vehicles are not permitted). **NO GUNS OR DOGS.**

**Hazards may include, but are not limited to:**

- Steep banks, cliffs, slips and rockfall,
- Numerous river and creek crossings subject to flash flooding,
- Adverse climate conditions resulting in slippery surfaces, particularly frost, ice, snow and rain,
- Vehicles and machinery, especially on roads and tracks,
- Activities of staff, recreational visitors and contractors,
- Uncontrolled scrub fires, unauthorized trespassers and poachers,
- Livestock and Beehives
- General farm hazards,

The Management of Orange Lakes NZ Limited and Hunter Valley Farming Co Limited are concerned about safety but as there are inherent dangers on this property you acknowledge that safety is your responsibility. The Leaseholder consents to access by users only on the basis that each person travels at his/her own risk, accepts full responsibility for his/her own safety, and accepts that the Leaseholder has no liability or responsibility of any sort for any injury, damage or accident to any person or property that enter Hunter Valley Station farmland and its surrounds. There is no cell phone coverage and breakdown services will not operate in the private area. Drivers also need to be self-sufficient and prepared for sudden changes in weather.

- The road is not checked daily so particular care is required at all times.
- You need to be prepared for the unexpected and drive at a speed that allows you to stop if a hazard arises. If you are in any doubt as to your ability to drive a vehicle taking into account the potential hazards you should not drive.
- You are advised to use a 4WD High Clearance vehicle with a snorkel. Check brakes after going through water.
- Please leave gates as you find them, and respect stock, property and other users. Do not block the road or obstruct gateways, tracks or entrances.
- Use of Station huts and camping is not permitted on the Station without the prior permission. Anyone found camping or using the huts without permission will be subject to immediate removal from the Station.
